- [Unemployment Insurance](#) - The Unemployment Insurance (UI) program pays benefits to workers who have lost their job and meet the program's [eligibility requirements](#). If you have become unemployed or partially unemployed, you may [file a UI claim](#).

- [Cares Act](#) - As part of the federal CARES Act, the federal government has approved funding for additional UI benefits to workers impacted by COVID 19, including the self-employed. The EDD has received only overarching information from the U.S. Department of Labor but needs further details to finish building the programming for implementing these changes.
- [Coronavirus 2019 \(COVID-19\) FAQ's](#) - Provides general guidance as to what programs are available and what situations may be applicable to your circumstances. Apply for the program you believe best fits your needs and the EDD will determine your eligibility for benefits.
- [State Disability Insurance Program](#) - The California State Disability Insurance (SDI) program provides short-term [Disability Insurance \(DI\)](#) and [Paid Family Leave \(PFL\)](#) wage replacement benefits to eligible workers who need time off work. You may be eligible for DI if you are unable to work due to non-work-related illness or injury, pregnancy, or childbirth. You may be eligible for PFL to care for a seriously ill family member or to bond with a new child.
